- The VA will not fund any ground or flight training toward the Private Pilot Certificate.
- The VA will not fund ground training beyond 30 hours or flight training beyond 35 hours for the Instrument Rating.

 The VA will not fund ground training beyond 36 hours or flight training beyond 120 hours for the Commercial Certificate.
- The VA will not fund the cost for FAA Practical Exams, \$800 per rating or certificate.
- The VA may limit annual funding, based on years of service and other factors.
